Service Awards

It is once again time to begin thinking about who we can nominate for the Service Awards from our community. A First Responder of the Year award and the Teacher of the Year award will be recognized at the Post and the County Level. The other awards that can go all the way to the National level are EMT of the Year, Firefighter of the Year, Law Enforcement Officer of the Year, and Legislator of the Year.

Dues increase:

National has ordered a dues increase effective January 1, 2016. The cost of State and National dues is increasing from \$25 to \$30. Post 116 dues currently are \$30, which allows no extra money to cover expenses the Post incurs each year for newsletters, etc. Do we want to increase our dues at this time? *The Post needs to vote and decide what we want to do*, so we will be presenting a few options at this months meeting.

- 1.) Do we want to leave the dues at \$30 through June 2016, and then raise them for the next membership year?
- 2.) Do we want to raise the dues in line with National, so the increase takes effect January 1, 2016?
- 3.) How much should the increase be? \$5? \$10? \$15 It costs the Post just under \$10 to cover newsletter costs per member each year.

<u>Roger Mathison spoke to</u> the members in attendance about the National Convention. Roger has been to the past 21 of 22 National Conventions. Some dignitaries had approached Roger and asked him to give insight to them, and then to our Post and others, as to why it is important for him to attend National Conventions. In this regard, Roger gave the Post nice insight on what is important to the National American Legion. Roger Mathison was really honored to have them ask and listen to him.

<u>Anyone interested in</u> helping on a committee to look into design options for a front entrance to the barroom? The options would be brought in front of the body in several months to see if it should be pursued or dismissed. A motion was made by Frank Mathison and seconded by Michael Miller to give approval to the Executive Committee to formulate a three person committee of volunteers to look into the scope of work for this project. Motion passed.
