

The WDVA has changed how the process goes for getting the Wisconsin Property Tax Credit for qualifying veteran or their surviving spouses. The new form is WDVA 2096 and it does need to be signed by an accredited service officer in order for it to be submitted. So qualifying veterans or surviving spouses can stop in and see us or any Wisconsin County Veteran Service Officer to get this paper work taken care of.
