Just incredible storms we've just experience in our community, flooding never seen like this before and hopefully never again. Just for some of you that haven't heard; our legion hall recently suffered severe damages to the hall and grounds. Our hall had 5.5-ft of water and mud going thru it in one storm and then a few days' later 6-inches. The water levels are down to normal levels now and a God sent of dry weather was upon us this week. Thankful no one was killed in these storms, if you seen what flooding did to our community and the coulee region, you won't believe no one was scathed.

Where we go from here is up to you! For starters, the community and legion family has spoken; by cleaning the hall and doing whatever we need to get us back on our feet again. I'm deeply touched and thankful for the people who have helped us so far! Thank you!

To ask for money and donations is not in me to do, I know other people need it more than we do, I'm telling you and other people to take care of family and friends first, and the legion will be ok. I've estimated costs up to \$200,000 dollars in damages to our legion and we did get \$25,000 from our insurance company. We have a 25,000 loan from the bank and might get another \$10,000 from the National American Legion. I've estimated it will take about \$60,000 to get the hall ready for winter, and for now that will be our focus.

Our first income event will be the Nov. 11th Chicken Q, I feel confident that will happen. If you want to donate Sam Club Gift cards for paper products that would be helpful.

Please look at our schedule of events (we're jammed packed till the end of the year), and pay attention to our next week's meeting time at our legion hall (bring your own chair). You might want to come to these meetings, a lot of big decisions will be made and information given out.

Strangely, this flood has made my focus on our country and great veterans ever more so! Family, God, and Country!

American Legion National Legacy Scholarship Run

The National Legacy Scholarship Run rolled into Onalaska Post 336 on Wednesday, August 22nd after a stop in the Onalaska Cemetery to lay wreaths at the graves on Post 336's namesakes, Otto W. Struck and August B. Klandrud, both of whom were died during World War I. There were check presentations at Post 336. The Westby/Coon Valley Legion Baseball Team donated \$250. The District 7 American Legion Riders presented checks totaling \$11,790.

Wisconsin American Legions contribution to the Legacy Scholarship Fund totaled \$45,000 and nationally, \$1,256,930 was the final tally!

September 11th Chaseburg Post 202 Flag Retirement

Title 36, Chapter 10 of US Code covers Patriotic Displays and includes the “Flag Code” which prescribes how the US Flag is to be displayed. The flag, when it is in such condition that it is no longer a fitting emblem for display, should be destroyed in a dignified way, preferably by burning.

Usually there is a dignified ceremony for flag retirement and every year Chaseburg Post 202 hosts such a ceremony on September 11th. This year was no different and we brought our flags to Chaseburg to take part in this event.

The flags that we had to hang up in the rafters of the chicken pits were dry enough to be brought over, so that was good. Chaseburg Auxiliary provided an excellent meal and there was much camaraderie in the Legion hall.
